



## JUNIOR'S UP IN SMOKE GIVEAWAY

May 01 - 28, 2022

### Official Rules

#### **How to get an entry:**

1. Guest must be at least 21 years of age, a member of Caesars Sportsbook at Muckleshoot Card and a member of Muckleshoot Rewards to participate.
  - a. Wager(s) must be placed with a Caesars Sportsbook at Muckleshoot Card.
  - b. Wager(s) must be placed at Caesars Sportsbook Book Windows at Muckleshoot Casino or Caesars Sportsbook Kiosks.
2. Participants may obtain physical entries at the Muckleshoot Rewards Center. Entry(s) must be redeemed daily from May 01 – 28, 2022, 8am – 11pm.
  - a. Receive one (1) free entry daily.
  - b. Receive one (1) bonus entry(s) for every \$100 (or more) individual wager(s) bet. Qualifying wager(s) placed must be presented the day of issuance. *(Qualifying wager(s) placed must be verified by a Ticket Writer of Caesars Sportsbook at Muckleshoot Casino).*
  - c. Once verified, a Verification Voucher will be issued by a Ticket Writer of Caesars Sportsbook at Muckleshoot Casino and will be presented to Muckleshoot Rewards Center for redemption of ticket entry(s).
    - i. Monday – Fridays, 9am – 11pm
    - ii. Saturday and Sundays, 7am – 11pm.
    - iii. Free/Bonus entries earned on Saturday, May 28, 2022, must be redeemed by 4:45pm.

#### **How to be selected:**

1. Participants must print their Muckleshoot Rewards card number on the back of their drawing entries and deposit it into the drawing drum.
  - a. The drawing drum will be located inside Caesars Sportsbook at Muckleshoot Casino.
    - i. Drawing drum will close three (3) minutes prior to the drawing time at 4:57pm.
  - b. Any promotional ticket(s) that have been modified and/or duplicated will be subject for immediate disqualification.
2. A physical drawing will be held at 5pm on Saturday, May 28, 2022, inside the Caesars Sportsbook at Muckleshoot Casino.
  - a. Drawing will be for two (2) verified winners.
3. Participants must be present to win and will have five (5) minutes to come to the Caesars Sportsbook at Muckleshoot Casino to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited, and another participant will be drawn.
  - a. Re-draws may continue until a winner is verified.
    - i. One (1) winner per award

#### **How to win:**

1. Two (2) ticket entries will be randomly selected from the drawing drum at Caesars Sportsbook at Muckleshoot Casino by a Promotions Specialist.
2. First ticket drawn will be awarded Yoder Smoker, Stick Burner and second ticket drawn will be awarded Yoder Smoker, Pellet Smoker with customizable paint options.

- a. Any entry drawn without a Muckleshoot Rewards card number or is illegible will be considered void and another entry will be drawn.

**Prize Pool:**

1. Verified participants will be awarded one (1) of the following;
  - a. Yoder Smoker, Stick Burner
    - i. Valued up to \$9,000
  - b. Yoder Smoker, Pellet Smoker with customizable paint options.
    - i. Valued up to \$10,000
2. Cash option is \$4,000 or Free Play option is \$5,000

**General Rules:**

1. All Participants must show their Muckleshoot Rewards Card and valid photo identification to be verified.
2. All games/rule inquiries will be handled by the Marketing Department. Their decision/ruling on any matters within the promotion will be deemed final.
3. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament.
4. The Tribe reserves the right to postpone, suspend or terminate the tournament or amend the rules at any time without notice to participants.
5. By entering or participating in the tournament, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice in for promotional purposes without further compensation or permission.
6. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes - unless expressly stated in the contest rules - are not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
7. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
8. Participants acknowledge that Prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
9. For tournaments that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
10. For promotions that require physical participation: All game pieces will be thoroughly and randomly shuffled by one promotions team member. Then a different promotions team member will place the pieces on the game board, ensuring that no piece's content is visible to anyone from any angle.
11. Participants are responsible for hearing tournament announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament

announcements. If the tournament involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.

12. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
13. The Tribe is not responsible for inability to enter a tournament or a drawing due to long lines or other causes.
14. Employees of Muckleshoot Casino and Bingo are not eligible to participate in tournaments or drawings.
15. Entries are not transferrable.
16. Violation of tournament rules may result in disqualification.
17. Any Participant dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
