



Muckleshoot Casino's Pay to Play Poker Promotion

Effective February 1, 2019 through February 1, 2020

Official Rules

ENTRIES:

1. Participants must be clocked in with their Players Club card in the Poker Room.
 - a. Upon accepting a seat at a live Poker table, dealers will swipe the players club card to start the accrual of play time.

RULES:

1. Guests who are clocked will receive a cash prize based on the number of hours played in a month, starting with a minimum of 20 hours:
 - a. 20 hours clocked in one month will earn \$50;
 - b. 40 hours clocked in one month will earn \$110;
 - c. 60 hours clocked in one month will earn \$180;
 - d. 80 hours clocked in one month will earn \$260;
 - e. 100 hours clocked in one month will earn \$350;
 - f. \$5 per hour for each hour exceeding 100 hours.
2. Team members that are **not** working are eligible for this promotion.
3. Prizes for hours completed in the active month by the end of the Sunday gaming day may be collected each Wednesday gaming day during the active month. Prizes for hours completed from 12:00am on the 1st through 11:59pm on the final day of the month may be collected on the 5th – 20th of the subsequent month.
4. The active month is defined as 12:00am on the 1st of the month through 11:59pm the final day of the month.
5. Hours are not transferrable from month to month.
6. Hours are not transferrable from guest to guest.
7. Guests are responsible to come to the Poker room to validate their eligibility and award on eligible days.
8. Guests are not required to collect their redemptions during the active month. However, when the guest comes to make a redemption the guest will be paid for all of his/her qualifying hours.
9. Guests Pay for Play hours can only be adjusted by Poker Room Manager and signed off by the Casino General Manager. A statement will also be provided as to why the hours were adjusted.

PRIZE TABLE

- \$50 with a minimum of 20 hours in a month
- \$110 with a minimum of 40 hours in a month
- \$180 with a minimum of 60 hours in a month
- \$260 with a minimum of 80 hours in a month
- \$350 with a minimum of 100 hour in a month
- \$5 per hour for each hour exceeding 100 hours

GENERAL RULES

1. All Participants must be 21 years or older and show their Preferred Players Card and proper ID to be verified.
2. All games/rule inquiries will be handled by the Poker Department. Their decision/ruling on any matters within the promotion will be deemed final.
3. The Muckleshoot Indian Tribe, any other sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the promotion.
4. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
5. By entering or participating in the promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice in for promotional purposes without further compensation or permission.
6. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes, unless expressly stated in the contest rules are not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
7. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
8. Participants acknowledge that Prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
9. For promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
10. Participants are responsible for hearing promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to promotion announcements. If the promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.

12. The Tribe is not responsible for inability to enter a promotion or a drawing due to long lines or other causes.
13. Employees of Muckleshoot Casino and Bingo are eligible to participate in this promotion and are eligible for all cash and prizes associated with it. Employees must be clocked in with their Preferred Players Club card.
14. Entries are not transferrable.
15. Violation of promotion rules may result in disqualification.
16. Any Participant dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
