



## MUCKLESHOOT CASINO "PROGRESSIVE HIGH HAND PROMOTION"

February 1, 2019 – April 30, 2019

### Entries:

1. Participants must be clocked in with their Preferred Player's Club card.
2. Must be in a Texas Hold'Em game participating in the promotion.
3. Must have a minimum of a full house to qualify.

### Rules

1. The hand must be dealt to a minimum of 3 players.
2. The pot must be at least \$1.
3. Must have a minimum of a full house, 1 hole card must play.
4. Promotion will run all times the Muckleshoot Poker Room is open, up to 24 hours a day 7 days a week
  - a) 3 tables or less will be paid at the rate of \$50 every 10 minutes
  - b) 4 to 9 tables will be paid at the rate of \$150 every 10 minutes
  - c) 10 + tables will be paid at the rate of \$250 every 10 minutes
5. Once the number of qualifying tables reach the level of 4 tables the higher rate of payment (150/10 minutes) will begin at the top of the next hour.
  - a. Once the levels of four tables are active, payments will begin at the next "progressive" level and the payment amounts will continue at the elevated levels until the number of qualifying tables drops below the level of four tables
  - b. Once the level of active tables falls below the key level of four and ten tables payment amounts do not recede until the top of the next hour
6. Minimum qualifier will be a full house, with one of the two hole cards playing as one of the qualifying five card hand.
  - a. In the event of there being no qualifying hand in the ten minute time period, the full amount of the high hand will rollover into the payment for the next period.

- b. If multiple persons are “tied” for the highest hand of the period, then the payment for that period will be split as equally as possible among persons with the same qualifying hand.
  7. A winner’s prize form must be filled out for all prizes greater than \$250 and a copy of the players’ valid ID and SS# must be obtained.
  8. If the player does not have a valid ID when collecting promotional money, they will be allowed up to 30 days to present valid ID. If the money is not collected in the specified time period, said money will be forfeited and will not be added to future promotions.
  9. The end of the high hand period will be indicated by the timer in the poker room.
    - a. All qualifying high hands must be called out by the dealer and acknowledged by the floor before the clock reaches the end of the high hand period.
    - b. In the event of a high hand called out by the dealer close to the expiration of the period, the decision of the floor will be final.
    - c. High Hand called out by poker players will not be considered a qualifying gesture. Hands must be called out by the dealer.
  10. Qualifying hands which have been disqualified due to collusion will not be posted.

**Prize Chart**

Tables	Amount	Time
1-3	\$50	Every 10 minutes
4-9	\$150	Every 10 minutes
10+	\$250	Every 10 minutes

**GENERAL RULES**

1. All participants must be 21 years old or older and show their Preferred Players Card and valid ID to be verified.
2. All games/rule inquires will be handles by the poker department. The decision/ruling on any matter within the promotion will be deemed final.
3. The Muckleshoot Indian Tribe, any other sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or

actions which arise out of or in any way related to the prize(s), or damages or losses related to the promotion.

4. The Tribe reserves the right to postpone, suspend or terminate the promotion or amend the rules at any time without notice to participants.
5. By entering or participating in the promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice in for promotional purposes without further compensation or permission.
6. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes, unless expressly stated in the contest rules are not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
7. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
8. Participants acknowledge that Prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
9. For promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
10. Participants are responsible for hearing promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to promotion announcements. If the promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
12. The Tribe is not responsible for inability to enter a promotion or a drawing due to long lines or other causes.
13. Employees of Muckleshoot Casino and Bingo are eligible to participate in this promotion and are eligible for all cash and prizes associated

with it. Employees must be clocked in with their Preferred Players Club card.

14. Entries are not transferrable.

15. Violation of promotion rules may result in disqualification.

16. Any Participant dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
