



## RISK OR REWARD

September 06, 13, 20 and 27, 2023

### Official Rules

#### **How to get an entry:**

1. Guest must be a member of Muckleshoot Rewards and at least 21 years of age to participate.
2. Participants may obtain entries by:
  - a. Receive one (1) free entry daily by inserting your Muckleshoot Rewards card in any Video Gaming Device (VGD) September 01 – 27, 2023 from 6am-7:59pm.
  - b. Receive one (1) bonus entry for every 2,500 base points earned on your Muckleshoot Rewards card while playing any of your favorite Video Gaming Device (VGD) and/or open a rating at Table Games, September 01 - 27, 2023 from 6am – 7:59pm.
  - c. Qualified participants will receive an offer to claim bonus entries Monday through Wednesday in September depending on their Monthly Rewards segment for each drawing as described under Active High or Active Low in the Monthly Rewards Program.
    - i. Entry(s)/Bonus entry(s) requires the inserting of a participants Muckleshoot Rewards card into a valid Video Gaming Device (VGD).
3. Entries will be purged each week following the 8pm drawing.

#### **How to be selected:**

1. Drawing(s) will be held on Wednesdays, September 06, 13, 20 and 27, 2023.
  - a. An Electronic Quick Draw (EQD) drawing will occur at 6pm, 7pm, 8pm.
    - i. Drawing will be for three (3) verified winners.
      1. A total of up to nine (9) winners per promotion date.
2. A winning announcement of the participant's name and Muckleshoot Rewards card number will be conducted via casino overhead during each scheduled drawing.
  - a. Participants must be present to win and will have five (5) minutes to come to the designated Promotions Area to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited, and another participant will be drawn.
  - b. Maximum of up to two (2) re-draws per drawing time.
3. Participants may only win once per drawing date.

#### **How to play/win:**

1. Each participant will select three (3) of forty-six (46) game pieces.
  - a. Participants will select game pieces according to the order in which they were verified; the first name verified will choose first, second name verified will choose second, and so on until each participant has a total of three (3) game pieces.
2. Once all three (3) participants have selected their game pieces, in the order of play, a Promotions Specialist will reveal the value of the first game piece beginning with Player 1. Player 1 will make the determination to "claim the reward" or "risk it" before moving on to Player 2 and Player 3.
  - a. Once a participant chooses to "claim the reward", their remaining game pieces if any, will be removed from the game, concluding the participant's play.
  - b. If a participant chooses to "risk it", that game piece will be removed from play and the participant will move on to the next game piece.

- i. This will repeat until the participant decides to “claim the reward” or when the participant has reached their third and final game piece.
- c. Participants may only claim one (1) reward.

**Prize Pool:**

- 1. Participants will be awarded the value of the game piece they choose to claim.

**General Rules**

- 1. All Participants must show their Muckleshoot Rewards card and valid photo identification to be verified.
- 2. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament/promotion.
- 3. The Tribe reserves the right to postpone, suspend or terminate the tournament/promotion or amend the rules at any time without notice to participants.
- 4. By entering or participating in the tournament/promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice for promotional purposes without further compensation or permission.
- 5. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes - unless expressly stated in the contest rules - are not permitted, provided that, in the event the Tribe at its sole discretion reserves the right to substitute cash in the event a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
- 6. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
- 7. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
- 8. For tournaments/promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino Resort or Bingo to participate on their behalf.
- 9. For promotions that require physical participation: All game pieces will be shuffled thoroughly by a team member of Muckleshoot Casino Resort. Then, randomly arranged on the game board by a

different team member of Muckleshoot Casino Resort, ensuring content of any game piece is not visible to anyone from any angle.

10. Participants are responsible for hearing tournament/promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament/promotion announcements. If the tournament/promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
12. The Tribe is not responsible for inability to enter a tournament/promotion or a drawing due to long lines or other causes.
13. Employees of Muckleshoot Casino Resort and Bingo are not eligible to participate in tournaments/promotions or drawings.
14. Entries are not transferrable.
15. Violation of tournament/promotion rules may result in disqualification.
16. All game/rule inquiries will be initially handled by the Marketing Department. Any Participant dissatisfied with a Marketing Department decision/ruling in a promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission. The Marketing Department's decision/ruling on any matter within the promotion will be final unless a timely written petition is filed with the Muckleshoot Gaming Commission.
17. Awarded Free Play must be played at least once through any valid video gaming device. All Free Play awards will expire 30 days after activation.
