



## **\$150,000 Carnival Cash Match**

**January 10 & 24, 2026**

### **Official Rules**

#### **Eligibility:**

1. Guests must be members of Muckleshoot Rewards and at least 21 years of age to participate.

#### **How to get an Entry:**

1. Participants may obtain entries by:
  - a. One free entry can be obtained daily beginning at 6am, January 1, 2026, until 8:59pm January 24, 2026, by inserting your Muckleshoot Rewards card into any valid Video Gaming Device (VGD).
  - b. Receive one (1) bonus entry for every 400 base points earned beginning at 6am, January 1, 2026, until 8:59pm January 24, 2026.
    - i. Base points may be earned on your Muckleshoot Rewards Card in either or both of the following ways:
      1. By playing any Video Gaming Device (VGD) with your Muckleshoot Rewards Card.
      2. By opening a rating and playing a table game.
    - ii. Participants will receive one (1) bonus entry for every 40 points earned on Wednesday, January 7 & 21, 2026, from 10am-8pm.
    - iii. Entries are deposited into a participant's account as they are accumulated.
    - iv. Point multipliers do not count towards earned entries.
    - v. All ticket entries will be purged following the final drawing on January 24, 2026.

#### **How to be Selected:**

1. Drawing(s) will be held on January 10 & 24, 2026
  - a. An Electronic Quick Draw (EQD) drawing will occur every hour from 4pm – 9pm.
    - i. Drawing will be for five (5) verified winners each drawing time.
    - ii. Total of up to thirty (30) winners per drawing date.
2. A winning announcement of the participant's name and Muckleshoot Rewards card number will be conducted via casino overhead during each scheduled drawing.
  - a. Participants must be present to win and will have five (5) minutes to come to the designated Promotions Area to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited, and another participant will be drawn.
    - i. Up to two (2) re-draws each drawing time.
    - ii. All participants must have a valid picture ID and Rewards Card within the five-minute check in time to be verified.
3. Participants may only win one (1) time per promotion date.

### **How to Play/Win:**

1. Verified winners will select one (1) of five (5) carnival themed game pieces in the order in which they were verified; The first participant verified will choose first, the second participant verified will choose second and so on.
2. Four (4) of the five (5) game pieces will reveal a Free Play prize in accordance with the matrix below and one (1) game piece will reveal an image of a Passista.
3. The four (4) participants who reveal Free Play will be awarded their Free Play prize and this will conclude their gameplay. The participants who reveal the image of a Passista will move on to the final portion of the promotion where they will continue to the Carnival Match & Win Game Board.
4. Twenty-five (25) Carnival themed symbols will be randomly arranged on the Carnival Match & Win Game Board. Each card features a uniquely vibrant carnival themed design.
  - i. The participant will begin to flip over the game pieces until they have matched three (3) game pieces of the same Carnival themed symbol.
  - ii. Each matching set of three (3) corresponds to a specific cash amount associated to the Gameboard Matrix below.
    1. In the event that the \$15,000 is won, the cash amount will be adjusted to \$10,000 for the remainder of the day's promotion.
5. At the conclusion of each drawing time all game pieces will be replaced so they will be available for each drawing hour of the promotion.

### **General Rules**

1. All Participants must show their Muckleshoot Rewards card and valid photo identification to be verified.
2. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament/promotion.

3. The Tribe reserves the right to postpone, suspend or terminate the tournament/promotion or amend the rules at any time without notice to participants.
4. By entering or participating in the tournament/promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice for promotional purposes without further compensation or permission.
5. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes - unless expressly stated in the contest rules - are not permitted, provided that, in the event the Tribe at its sole discretion reserves the right to substitute cash in the event a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
6. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
7. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
8. For tournaments/promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino Resort to participate on their behalf.
9. For promotions that require physical participation: All game pieces will be shuffled thoroughly by a team member of Muckleshoot Casino Resort. Then, randomly arranged on the game board by a different team member of Muckleshoot Casino Resort, ensuring content of any game piece is not visible to anyone from any angle.
10. Participants are responsible for hearing tournament/promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament/promotion announcements. If the tournament/promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
12. The Tribe is not responsible for inability to enter a tournament/promotion or a drawing due to long lines or other causes.
