



Road to the Cup
June 3, 10, 17, & 24, 2026
Official Rules

Eligibility:

1. Guests must be members of Muckleshoot Rewards and at least 21 years of age to participate.

How to get an Entry:

1. Participants may obtain entries by:
 - a. One free entry can be obtained daily beginning at 6am, June 1, 2026, until 8:59pm June 24, 2026, by inserting your Muckleshoot Rewards card into any valid Video Gaming Device (VGD).
 - b. Receive one (1) bonus entry for every 400 base points earned from 6am, June 1, 2026, until 8:59pm June 24, 2026.
 - i. Base points may be earned on your Muckleshoot Rewards Card in either or both of the following ways:
 - By playing any Video Gaming Device (VGD) with your Muckleshoot Rewards Card.
 - By opening a rating and playing a table game.
 - ii. Entries are deposited into a participant's account as they are accumulated.
 - iii. Point multipliers do not count towards earned entries.
 - iv. All ticket entries will be purged following the final drawing on June 24, 2026.

How to be Selected:

2. Drawing(s) will be held on June 3, 10, 17, & 24, 2026
 - a. An Electronic Quick Draw (EQD) drawing will occur every hour from 5pm-9pm.
 - i. Drawings will be for four (4) verified winners.
 - ii. A total of twenty (20) winners per drawing date.
3. A winning announcement of the participant's name and Muckleshoot Rewards card number will be conducted via casino overhead during each scheduled drawing.
 - a. Participants must be present to win and will have five (5) minutes to come to the designated Promotions area to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited, and another participant will be drawn.
 - i. Re-draws until all four (4) participants are verified each drawing time.
 - ii. All participants must have a valid picture ID and Rewards Card within the five-minute check in time to be verified.
4. Participants may only win one (1) time per promotion date.

How to Play/Win:

1. In the order in which they were verified, participants will select one (1) of four (4) Country Flags on the interactive touchscreen media gameboard. The first participant verified will choose first; the second participant verified will choose second, and so on.
 - a. The selected flag will be used to identify the participants on the gameboard.
2. Each participant will get one (1) penalty kick. Two (2) will miss; Two (2) will score and move on to the final stage.

- a. The two (2) Participants who did not score will be awarded a Free Play amount according to the matrix below, and that will conclude their game play.
3. The Two (2) participants who scored will move on to our Final Round on the interactive touchscreen media gameboard, and each take turns kicking to win up to \$2,500 Cash.
4. The first participant to score two (2) goals wins the \$2,500 cash prize.
 - a. First Place Receives \$2,500 in Cash; Second Place Receives \$1,000 in Cash.
5. This promotion contains a "Progressive Jackpot" which may be randomly triggered at any penalty kick during gameplay.
 - a. Progressive Jackpot starts at \$3,000 in Cash. It increases by \$500 every hour if not triggered.
 - b. The Progressive Jackpot will not re-set unless it is won; it will continue to accrue through each promotional date.
 - i. If triggered on the First Stage, the triggering participant will receive the full Jackpot amount. All other participants receive \$300 in Free Play and will conclude the game.
 - ii. If triggered on the Final stage, the triggering participant will receive the full jackpot amount. The other participant receives \$1,000 in Cash and will conclude the game.
6. Additionally, the "Hot Zone" bonus feature may occur up to two (2) times per promotional day at random during penalty kicks on the Final Stage.
 - a. One (1) scoring zone will be randomly identified as the "Hot Zone." If selected and scored through a penalty kick, the Participant will move on to choose from a set of eight (8) prize pieces for their chance to win up to \$750 in Cash!
 - i. Participant will choose from one (1) of eight (8) prize pieces in the promotional area.
 - ii. Participant will be awarded the Cash amount shown on the prize piece in accordance with the "Hot zone Cash" matrix below.
 - iii. The Cash will be added to their total winnings according to the "Hot Zone Cash" matrix below.
7. At the conclusion of each drawing time all game pieces will be replaced so they will be available for each drawing hour of the promotion.

Progressive Jackpot:

Starts at \$3,000. Increases by \$500 every hour it is not hit. The jackpot will not re-set unless it is hit; it will continue through each promotional day. Maximum Jackpot Amount: \$12,500

General Rules:

1. All Participants must show their Muckleshoot Rewards card and valid photo identification to be verified.
2. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament/promotion.
3. The Tribe reserves the right to postpone, suspend or terminate the tournament/promotion or amend the rules at any time without notice to participants.
4. By entering or participating in the tournament/promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice for promotional purposes without further compensation or permission.
5. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes - unless expressly stated in the contest rules - are not permitted, provided that, in the event the Tribe at its sole discretion reserves the right to substitute cash in the event a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
6. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
7. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$2000 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
8. For tournaments/promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino Resort to participate on their behalf.
9. For promotions that require physical participation: All game pieces will be shuffled thoroughly by a team member of Muckleshoot Casino Resort. Then, randomly arranged on the game board by a different team member of Muckleshoot Casino Resort, ensuring content of any game piece is not visible to anyone from any angle.
10. Participants are responsible for hearing tournament/promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament/promotion announcements. If the tournament/promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
12. The Tribe is not responsible for inability to enter a tournament/promotion or a drawing due to long lines or other causes.
13. Employees of Muckleshoot Casino Resort are not eligible to participate in tournaments/promotions or drawings.
14. Entries are not transferrable.
15. Violation of tournament/promotion rules may result in disqualification.

16. All game/rule inquiries will be initially handled by the Marketing Department. Any Participant dissatisfied with a Marketing Department decision/ruling in a promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission. The Marketing Department's decision/ruling on any matter within the promotion will be final unless a timely written petition is filed with the Muckleshoot Gaming Commission.
17. Awarded Free Play must be played at least once through any valid video gaming device. All Free Play awards will expire 30 days after activation.
