

Peppermint Payouts December 26, 2025 Official Rules

Eligibility:

1. Guests must be members of Muckleshoot Rewards and at least 21 years of age to participate.

How to get an Entry:

- 1. Participants may obtain entries by:
 - a. Receive one (1) free entry on December 26, 2025, by inserting your Muckleshoot Rewards card in any valid Video Gaming Device (VGD) from 6am-9:29pm.
 - b. Receive one (1) bonus entry for every 200 base points_earned beginning at 6am, December 26, 2025, until 9:29pm December 26, 2025.
 - i. Base points may be earned on your Muckleshoot Rewards Card in either or both of the following ways:
 - a. By playing any Video Gaming Device (VGD) with your Muckleshoot Rewards
 - b. By opening a rating and playing a table game.
 - ii. Entries are deposited into a participant's account as they are accumulated.
 - iii. Point multipliers do not count towards earned entries.
 - iv. All ticket entries will be purged following the final drawing on December 26, 2025.

How to be Selected:

- 1. Drawing will be held on December 26, 2025.
 - a. An Electronic Quick Draw (EQD) drawing will occur from 5pm 9:30pm every half hour.
 - i. Drawing will be for eight (8) verified winners at each drawing time.
 - ii. Total of up to eighty (80) winners per drawing date.
- 2. A winning announcement of the participant's name and Muckleshoot Rewards card number will be conducted via casino overhead during each scheduled drawing.
 - a. Participants must be present to win and will have five (5) minutes to come to the designated Promotions Area to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited.
 - i. No re-draws.
 - ii. All participants must have a valid picture ID and Rewards Card within the fiveminute check in time to be verified.
- 3. Participants may only win one (1) time per promotion date.

How to Play/Win:

1. In the order in which they were verified, winners will select one of eight (8) peppermint candy cane(s) from a gift box; The first participant verified will choose first, the second participant verified will choose second, and so on.

- 2. Each candy cane will be marked with a free play amount in accordance with the matrix below.
- 3. The participant will be awarded the free play amount revealed on their Candy Cane and this will conclude their gameplay.
- 5. At the conclusion of each half hour's promotional activity, all candy canes will be replaced so the same options will be available for the following hour's drawing.

General Rules:

- 1. All Participants must show their Muckleshoot Rewards card and valid photo identification to be verified.
- 2. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament/promotion.
- 3. The Tribe reserves the right to postpone, suspend or terminate the tournament/promotion or amend the rules at any time without notice to participants.
- 4. By entering or participating in the tournament/promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice for promotional purposes without further compensation or permission.
- 5. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules are not permitted, provided that, in the event the Tribe at its sole discretion reserves the right to substitute cash in the event a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
- 6. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
- 7. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
- 8. For tournaments/promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino Resort to participate on their behalf.

- 9. For promotions that require physical participation: All game pieces will be shuffled thoroughly by a team member of Muckleshoot Casino Resort. Then, randomly arranged on the game board by a different team member of Muckleshoot Casino Resort, ensuring content of any game piece is not visible to anyone from any angle.
- 10. Participants are responsible for hearing tournament/promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament/promotion announcements. If the tournament/promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
- 11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
- 12. The Tribe is not responsible for inability to enter a tournament/promotion or a drawing due to long lines or other causes.
- 13. Employees of Muckleshoot Casino Resort are not eligible to participate in tournaments/promotions or drawings.
- 14. Entries are not transferrable.
- 15. Violation of tournament/promotion rules may result in disqualification.
- 16. All game/rule inquiries will be initially handled by the Marketing Department. Any Participant dissatisfied with a Marketing Department decision/ruling in a promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission. The Marketing Department's decision/ruling on any matter within the promotion will be final unless a timely written petition is filed with the Muckleshoot Gaming Commission.
- 17. Awarded Free Play must be played at least once through any valid video gaming device. All Free Play awards will expire 30 days after activation.
