

The Pirates Trove March 15 & 22, 2025 Official Rules

Eligibility:

1. Guest(s) must be a member of Muckleshoot Rewards and at least 21 years of age to participate.

How to get an Entry:

- 1. Participants may obtain entries by.
 - a. Receive one free entry daily on the day of the promotion (March 15 & 22, 2025) from 6am 7:59pm.
 - b. Receive one (1) bonus entry for every 400 base points earned on your Muckleshoot Rewards card while playing any of your favorite Video Gaming Device (VGD) and/or open a rating at Table Games on March 15 & 22, 2025 from 6am 7:59pm.
 - *i*. Entries are deposited into a participant's account as they are accumulated. (Point Multipliers do not count toward earned entries.)
 - c. All entries will be purged following the last promotion on March 22, 2025.

How to be Selected:

- 1. Drawing(s) will be held on March 15 & 22, 2025.
 - a. An Electronic Quick Draw (EQD) drawing will occur every hour from 5pm-8pm with the grand finale at 9pm.
 - i. Drawings will be for six (6) verified winners.
 - 1. A total of twenty-four (24) winners per drawing date.
- 2. A winning announcement of the participant's name and Muckleshoot Rewards card number will be conducted via casino overhead during each scheduled drawing.
 - a. Participants must be present to win and will have five (5) minutes to come to the designated Promotions area to be verified. If a participant does not claim their winning entry within five (5) minutes, the winning entry will be forfeited, and another participant will be drawn.
 - i. Up to three (3) re-draws each drawing time.
- 3. Participants may only win once per drawing date.

How to Play/Win:

- 1. In the order that the six participants were verified, they will each take turns rolling five dice.
- 2. The two participants who roll the highest hand in accordance with the ledger below will be invited back to the grand finale at 9pm for a chance of winning up to \$15,000 in cash. Ex: If one participant rolls a five of a kind, and one participant rolls a pair, the contestant with the five of a kind would qualify to return at 9pm.
- 3. All participants will receive \$300 in free play.
 - Free play will be awarded after the duration of the drawing.
- 4. At 9pm all eight (8) participants will return to have a chance of winning up to \$15,000 in cash.
- 5. In the order that the 8 finalists were verified, they will all line up and select a pirate scroll from the promotions area.

- 6. Participants will be instructed not to open their pirate scroll until directed to do so by a Marketing Representative.
- 7. After each participant has selected a pirate scroll, they will be instructed to open their pirate scroll at the same time by a Marketing Representative.
- 8. Seven (7) of the pirate scrolls will reveal a cash prize in accordance with the matrix below, and one (1) will reveal a treasure chest.
- 9. The participant who reveals the treasure chest will move on to choose from one (1) of four (4) treasure chests placed in the promotions area.
- 10. Each treasure chest will contain a cash prize in accordance with the prize matrix below.
- 11. Once the participant has made their selection, the cash prize will be revealed, and the participant will be awarded the amount they have chosen.

General Rules:

- 1. All Participants must show their Muckleshoot Rewards card and valid photo identification to be verified.
- 2. The Muckleshoot Indian Tribe (Tribe), any other sponsor and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the tournament/promotion.
- 3. The Tribe reserves the right to postpone, suspend or terminate the tournament/promotion or amend the rules at any time without notice to participants.
- 4. By entering or participating in the tournament/promotion, participants grant the Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness or voice for promotional purposes without further compensation or permission.
- 5. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules - are not permitted, provided that, in the event the Tribe at its sole discretion reserves the right to substitute cash in the event a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
- 6. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of prizes.
- 7. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
- 8. For tournaments/promotions that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino Resort or Bingo to participate on their behalf.
- 9. For promotions that require physical participation: All game pieces will be shuffled thoroughly by a team member of Muckleshoot Casino Resort. Then, randomly arranged on the game board by a different team member of Muckleshoot Casino Resort, ensuring content of any game piece is not visible to anyone from any angle.
- 10. Participants are responsible for hearing tournament/promotion announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to tournament/promotion announcements. If the tournament/promotion involves a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
- 11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
- 12. The Tribe is not responsible for inability to enter a tournament/promotion or a drawing due to long lines or other causes.
- 13. Employees of Muckleshoot Casino Resort and Bingo are not eligible to participate in tournaments/promotions or drawings.
- 14. Entries are not transferrable.
- 15. Violation of tournament/promotion rules may result in disqualification.
- 16. All game/rule inquiries will be initially handled by the Marketing Department. Any Participant dissatisfied with a Marketing Department decision/ruling in a promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission. The Marketing Department's decision/ruling on any matter within the promotion will be final unless a timely written petition is filed with the Muckleshoot Gaming Commission.

17. Awarded Free Play must be played at least once through any valid video gaming device. All Free Play awards will expire 30 days after activation.
